TO: ALL PSAC/UNW MEMBERS AT THE HAMLET OF FORT PROVIDENCE

RE: BARGAINING UPDATE – TENTATIVE AGREEMENT REACHED

A tentative agreement on behalf of PSAC/UNW members working for the Hamlet of Fort Providence was reached on January 24, 2018. The new agreement is for three years, and will expire on June 30, 2020.

Unless otherwise specified, the proposed changes would become effective the date the new collective agreement is ratified.

As you will see, the Union and management have agreed on a number of changes to the collective agreement. The most important changes are:

1. Economic increases:

| July 1, 2017 | 1.75% |
|--------------|-------|
| July 1, 2018 | 1.75% |
| July 1, 2019 | 1.75% |

2. Vacation Travel Assistance (VTA)

On April 1, 2018, Vacation Travel Assistance will be increased by \$150 per year to \$1850. On April 1, 2019, it will increase another \$150 to \$2000 per year.

3. Hunting, Fishing and Harvesting Leave

This leave under Article 21.07 will increase to four (4) days from threeand-a-half days in order to meet traditional hunting, fishing, harvesting or cultural needs. These are not all of the changes that we have agreed to, and you will get a chance to review all of the details before you vote on this agreement.

As mentioned above, your bargaining team of Albertine Canadien, Cliff McLeod and Daniel Kinsella, PSAC Negotiator, unanimously recommend acceptance of this tentative agreement.

If a majority of those voting ratifies this tentative agreement, your bargaining team will sign a new collective agreement with the Hamlet of Fort Providence. All Union members are encouraged to attend the ratification meeting and vote.
